- the applicant has been imposed a final judgement for fraud, corruption, involvement in criminal organizations or other illegal activities.

Will also be excluded from the contributions of paragraph 1, enterprises in difficulty as defined in article 2 paragraph 18 of Reg .( EU) No . 651/2014 of 17 June 2014 .

The Association Friuli Venezia Giulia Film Commission may require other tests to applicants demonstrating that they are not in one of the situations described above .
